The Berkshire Regional Transit Authority is requesting submissions for the sale of used vehicles and/or equipment. This sale includes used surplus public transit vehicles.

All Lots will be sold as is, where is. Vehicles will be sold with a bill of sale and transfer of title. All vehicles must be towed from the premises post award and purchase. All Lots must be removed from BRTA property by the awardee within fifteen (15) business days of award notification. Repair, scrap, or any salvage activities will not be permitted at any time while the vehicle or equipment resides on BRTA property. All Lots are available for visual inspection by appointment only weekdays between 9:00 AM and 4:00 PM at the BRTA Operations/Maintenance Facility, located at 67 Downing Parkway, Pittsfield MA. Appointments to inspect Lots must be made in advance by contacting Rauley Caine, General Manager, at (413) 499-2782 – ext. 2902.

Sealed submission(s) must be received by the Berkshire Regional Transit Authority no later than 4:00 PM on January 31, 2023. All submissions must include the proper forms supplied by the Authority for this sale.

Submission Instructions

The enclosed forms contained within this document constitute an integral part of the Submission Package for vehicle sale provided to all interested parties. All forms must accompany each sealed submission, individually, and must be fully completed as required.

To be considered, all sealed submissions must be received at the BRTA administrative offices (located at 1 Columbus Avenue, Suite 201, Pittsfield, MA 01201) no later than 4:00 PM on January 31st, 2023

Award of sale notification will be provided to the party with the highest dollar value submission for each lot at the time of submission opening. Lots will be awarded individually. Only parties with the highest value submission for any Lot will be contacted using the contact information provided on the completed submission form. Successful Parties must submit payment by certified bank check, or money order, in the amount of the successful submission within ten (10) business days following the award notification. **Payable to: Berkshire Regional Transit Authority.**
