# 3) ADMINISTRATOR'S REPORT

## **STATE**

R. Malnati signed the contract for BRTA's Fair Share funding and is waiting for it to be executed. Funding should be received in November but is unsure on if the funding will need to be expended by June 30. Most of the RTAs submitted a grant application to DOT for this year's Try Transit event. For this program last year, BRTA created a thermometer poster with a ridership goal. The same will be done this year. We applied for funding to offset fare revenue to replicate that 6-week program from the Friday after Thanksgiving until the end of the calendar year. The application was sent in today and included a fare free period of June and July. Mr. McNally asked if it was statewide. Mr. Malnati remarked it is statewide but only during the holiday season. The Try Transit Event and the options for the Fair Share Funding will be discussed regarding extending service until about 9:30 PM. These are voteable items at this meeting.

# **OPERATIONS**

Recently the BRTA participated in a Select Board meeting in Adams in a discussion about new bus stop signs. Also, BRTA discussed the services that the BRTA offers at the Lanesboro Select Board. Both meetings were successful and led to more people learning about the BRTA. Ridership, so far, for this quarter is 12% over the previous year for Fixed Route and Paratransit is closer to 10%.

#### **APTA EXPO 2023**

R. Malnati and S. Vallieres went to the APTA Expo in Florida. This is a once in a three-year event with a multitude of transit vendors for vehicles and services. BRTA spoke with many vendors and attended training sessions including hydrogen systems. R. Malnati gave a brief description of hydrogen and fuel cell vehicle options.

# PILOT BERKSHIRE FLYER 23 SEASON CONCLUDES

R. Malnati stated the Berkshire Flyer ended on October 8<sup>th</sup> for the season. There were approximately 1,227 riders for the extended season from Memorial Day to Columbus Day weekend. DOT, Amtrak, and CSX will have a meeting next month to discuss the outcome from this season, what improvements are needed, and expectations for the 2024 season. There was a discussion on specifics of the train and that BRTA is part of the Flyer Steering Committee.

#### 4) FARE FREE EVENT - VOTE

R. Malnati stated the BRTA Advisory Board will vote for the Fare Free Event for the Holiday 2023 season and June-July 2024 to submit the grant application, which includes marketing funds. R. Reilly made a motion to accept the Fare Free Event and D. McNally seconded the motion. All stated aye and the Fare Free Event was unanimously passed.

#### 5) NEW SERVICE-PUBLIC COMMENT - VOTE

R. Malnati proposed adding new evening service to weekday and Saturday service using the Fair Share Funding when it is available. The Proposed Service material was handed out at the meeting and R. Malnati went through the proposal. BRTA would like a vote to proceed with a public comment period to gather customer feedback on the proposed additional service. BRTA annually evaluates the performance of its bus routes and hours and provides service change options. There are two options we will present to the public. The first option is all routes extending evening service at a cost of \$276,000 from February 1 to June 30, but would need to hire 3 new operators. If we cannot hire new people, the second option costs \$168,000 by extending workdays for a couple routes. BRTA would like to go to public comment issuing a press release and holding meetings to discuss with the community. The Advisory Board can reconvene on November 30<sup>th</sup> to provide the information gathered and a decision.

There was a discussion on the positive possibility of moving forward, the driver's training program, and driver's overtime. There was also a question of sustainability beyond the initial funding. R. Malnati is looking for more information on funding and different funding mechanisms.

D. McNally made a motion to proceed with the New Service-Public Comment period and A. Potter seconded the motion. All stated aye and the New Service-Public Comment was unanimously passed.

#### 7) BUDGET YTD

Mr. Malnati provided an overview of the BRTA budget for September 2023. We are above budget for Paratransit and Fixed Route fares while under budget in expenses. At the next Board Meeting we will be making a budget amendment, to include additional state funds, and less federal funds.

# 8) RIDERSHIP YTD

Mr. Malnati stated that Ridership for fixed route for September is 9% over last year's amount. This is the first month we fell below a double-digit increase. Paratransit is also 9% over last year's number. COA and ADA are up about 500 more trips. Wheelchair ridership, Route 1, is close to what the 34 was for the month. This proves the bus goes where customers want, when they want to go there and is more economical than the Paratransit.

Ms. Fontaine asked if this was duplicated or unduplicated riders? Mr. Malnati remarked duplicated. Bicycle transports are up one hundred and a half from last year. The final page of our performance measures posted to the website shows Route 1 has the number one ridership for the period, 34 is the second highest, followed close by the Route 2. Routes 11 and 14 went down, primarily impacted by driver shortages.
