## Berkshire Regional Transit Authority Finance/Audit Committee Members present:

R. Malnati called the Finance/Audit Committee meeting to order at 3:15 PM.

# 1. Approval of Minutes for March 28, 2024 - VOTE

The Finance Committee members reviewed the minutes of the March 28, 2024 meeting. D. McNally made the motion to accept the minutes, was seconded by S. Irvin, and was approved by all.

## 2. FY 25 Draft BRTA Budget Review

R. Malnati reviewed the FY 25 Budget Assumption and the BRTA FY25 Draft Budget documents with the Finance Committee. The budget is conservative using the Governor's January level-funded budget and the decrease in the Federal apportionment based upon the 2020 census. The grants BRTA was awarded is reflected in the budget (Try Transit, BRTA/PVTA/FRTA Connector, and 2 paratransit grants). For these grants, BRTA will be hiring 2 new fixed route operators and 5 new paratransit operators. BTM ratified the Collective Bargaining Agreement which showed an increase in Operating. This is a 3-year contract and has a more competitive wage. The Fair Share Act funding will cover this increase in costs. Fuel and insurance also contributed to the budget increase. The interest rate for borrowing is programmed at 4.5% based upon research. This budget is a 17.5% increase and includes 4% increase to BRTA Administrative Staff. Discussion:

It was noted that BRTA is increasing costs, but also increasing service.

## 3. FY 25 Draft BRTA Budget- VOTE

After discussion on the draft budget review by R. Malnati, D. McNally made the motion to approve and recommend the FY 25 draft budget to the BRTA Advisory Board as presented. This motion was seconded by S. Lamb and was approved by all.
