1) ROLL CALL

D. McNally called the Advisory Board Meeting to order at 4:01 PM stating this meeting will be recorded for the purposes of the notes of the Board Minutes.

2) ADMINISTRATORS REPORT

R. Malnati shared information about the Connectivity Grant between BRTA, PVTA, and FRTA. R. Caine-PVTA flew to the Pittsburgh area to look at six buses retiring from service. Four will be retiring next month and two near the end of June. These will be the six buses used for this service. Two buses will go to BRTA, two will go to FRTA, and two will go to PVTA. One additional vehicle will be from GATRA (Greater Attleboro Taunton RTA) and he received the title yesterday. This vehicle will be towed to BRTA from Springfield shortly. The final vehicle will come from the MassDOT pool once their procurement for refurbishing the buses is awarded and completed. He reviewed a draft of the grant contract today and the original budget amount needs to be verified. The Secretary of Transportation will fully execute the contract and then BRTA will be able to start using the funds for items like mobile lifts.

D. McNally discussed starting to publish the schedule a couple months in advance, to which R. Malnati agreed. BRTA's micro-transit study conducted by N-CATT has asked if any BRTA Advisory Board member would like to participate in the stakeholder meetings. This would be a remote meeting lasting about 60 minutes. If anyone is interested in participating, please let Bob know.

MassDOT informed BRTA last week that we have been selected for an audit. We are pulling the requested information together and will submit it to DOT in March. Once they receive the packet, they will review, and schedule a site visit.

3) MINUTES OF JANUARY 30, 2025 MEETING-VOTE

J. Boyle made a motion to accept the Minutes of January 30, 2025 meeting and J. Minacci seconded the motion. The Minutes of January 30, 2025 meeting were approved with the abstentions of S. Lamb and F. Abbott.

4) RESOLUTION OF THE ADVISORY BOARD - VOTE

Mr. McNally stated the Resolution of the Advisory Board was not on the agenda at the last meeting and BRTA needs to submit to FTA mid-March. The BRTA Administrator is able to file applications and execute awards for federal assistance, as well as annual certifications and assurances and other documents FTA may require. FTA informed all recipients that this document must be on file before any grant application will be reviewed. He was asked if it must be done annually. Mr. Malnati remarked, they didn't tell us that, but probably. M. Morin made the motion to approve the Resolution of the Advisory Board and M. Reilly seconded the motion. All stated aye and the Resolution of the Advisory Board was unanimously approved. J. Minacci asked if this was just for the Federal grants to which R. Malnati remarked yes.

R. Malnati scheduled the next meeting for March 27, 2025 at 4:00 PM.
